The Respondent, in an e-mail, also dated November 22, 2011 stated it was in agreement with the postponement being requested.

DECISION

REASONS

The Board is of the opinion that the parties have proven to the Board they are working together to resolve the issues and have met the conditions set out in two previous decisions of the Board.
