# DECISION OF Shannon Boyer, Presiding Officer John Braim, Board Member Judy Shewchuk, Board Member

### **Procedural Matters**

[1] The Board members stated they had no bias with respect to this file and upon questioning by the Presiding Officer, the parties stated that they did not object to the Board's composition.

#### **Preliminary Matters**

[2] The Respondent made a recommendation to the Board to reduce the 2014 assessment to \$672,000 for the reason that there was an issue with the modelling process and it was appropriate to reduce the assessment by 20%. The Complainant informed the Board that the Respondent's recommendation was acceptable.

#### **Background**

[3] Municipally addressed as 8735-126 Ave. NW, the subject is a 46,487.97 square foot lot used for vehicle and trailer storage. The 2014 assessment is \$840,500.

#### Issues

[4] Is the 2014 assessment appropriate and equitable?

### Position of the Complainant

[5] The Complainant entered a written brief and rebuttal into evidence, but further presentation of evidence was not required in light of the Respondent's recommendation to reduce the assessment.

# **Position of the Respondent**

[6] The Respondent entered a written brief into evidence, but further presentation of evidence was not required in light of the recommendation to reduce the assessment and the Complainant's acceptance.

# **Decision**

[7] The Board reduces the 2014 assessment to \$672,000.

# Reasons for the Decision

[8] Upon hearing the Respondent's recommendation to reduce the assessment from \$840,500 to \$672,000 to correct a modelling issue, and upon noting that the Complainant finds the reduction acceptable, the Board finds that the appropriate assessment is \$672,000.

# **Dissenting Opinion**

[9] There was no dissenting opinion.
