MINISTERIAL ORDER

IN THE MATTER OF THE IMPROVEMENT DISTRICTS ACT
andTHE ESTABLISHMENT OF THE HAMLET OF WABASCA-DESMARAIS

WHEREAS, section 2 of the above noted Statute authorizes the Minister of Municipal Affairs to declare any given area to be a hamlet and to designate its boundaries, and

WHEREAS, because of land tenure and development taking place within the Wabasca-Desmarais area, it is desirable to declare the Hamlet of Wabasca-Desmarais and establish the boundaries.

NOW, THEREFORE, I, Dick Johnston, Minister of Municipal Affairs, by virtue of the authority vested in me by the aforementioned Statute, DO HEREBY ORDER:

1. That the lands contained within the area outlined in red on Schedule "A", attached, shall be declared as the Hamlet of Wabasca-Desmarais.
2. That the boundaries of the Hamlet of Wabasca-Desmarais shall be established as outlined in Schedule "A", attached, or more specifically defined as follows:
