MINISTERIAL ORDER

---

FORMATION OF THE MUNICIPAL DISTRICT OF FORTY MILE, NO. 2

Whereas the Co-Terminous Boundary Commission has recommended certain changes in municipal boundaries as designated in the Bow Island-Foremost Co-Terminous Area, No. 2, and

Whereas it is deemed advisable and expedient to do so.

Now therefore, pursuant to the authority vested in me by section 19 of The Municipal District Act, being chapter 151 of the Revised Statutes of Alberta, 1942, the undersigned hereby orders that:

Part of Improvement District No. 1,  
Part of Improvement District No. 11,  
Part of The Municipal District of Warner No. 4,  
Part of The Municipal District of Bow Island No. 13,  
and Part of The Municipal District of Burlington No. 2,

shall be merged into one new municipal district to be known and designated as The Municipal District of Forty Mile No. 2, and shall on and after January 1st, 1954, comprise the following lands:

The northerly one-third of township 3; all of townships 4 to 6 inclusive; all of township 7 excepting thereout sections 1, 12, 13, 24, 25 and 36; the west half of township 8; and sections 4 to 9 inclusive in township 9; all in range 5;

All of townships 1 to 8 inclusive; and the southerly one-third of township 9; all in range 6;

All of townships 1 to 9 inclusive; all in range 7;

All of townships 1 to 9 inclusive; all of township 10 excepting thereout sections 1, 12, 13, 24, 25, 36 and the east halves of sections 2, 11, 14, 23, 26 and 35; all of township 11 excepting thereout sections 1, 12, 13, 24, 25, 36 and the east halves of sections 2, 11, 14, 23, 26 and 35; all of township 12 lying south of the South Saskatchewan River excepting thereout sections 1, 12, 13, 24, and the east halves of sections 2, 11, 14, 23 and those portions of section 25 and the east half of section 26 lying south of the South Saskatchewan River; and that portion of township 13 lying south of the South Saskatchewan River; all in range 8;

All of townships 1 to 12 inclusive; and that portion of township 13 lying south of the South Saskatchewan River; all in range 9.

All of townships 1 to 11 inclusive; and those portions of townships 12 and 13 lying south and east of the South Saskatchewan River; all in range 10.

All of township 1; all of township 2 excepting thereout sections 19, 29, 30, 31, 32 and those portions of sections 17, 18 and 20 lying north and west of the Milk River; the easterly two-thirds of township 3; all of townships 4 to 10 inclusive; and those portions of townships 11 and 12 lying south and east of the South Saskatchewan River; all in range 11;

All of townships 1 and 2 lying south and east of the Milk River; all of townships 4 to 10 inclusive; and that portion of township 11 lying south of the South Saskatchewan River; all in range 12;

All of townships 4 to 6 inclusive; and sections 3, 4, 5, 6 and the south halves of sections 1, 2, 7, 8, and 9 in township 7; all in range 13;

All of townships 5 and 6; and sections 1 to 12 inclusive and sections 16, 17, 18 and the south halves of sections 14 and 15 in township 7; all in range 14;

All the above described lands lying west of the fourth meridian excepting thereout the land comprising any incorporated Town or Village situate therein.

That the area included by this Order within the above described boundaries of the Municipal District of Forty Mile No. 2, shall be and is divided into seven divisions for electoral purposes described as follows:

Division No. 1;

All of townships 1 to 4 inclusive; and the south half of township 5; all in range 9;

All of townships 1 to 4 inclusive; and the south half of township 5; all in range 10;

All of township 1; all of township 2 excepting thereout sections 19, 29, 30, 31, 32 and those portions of sections 17, 18 and 20 lying north and west of the Milk River; the easterly two-thirds of township 3; all of township 4; and the south half of township 5; all in range 11;

All of townships 1 and 2 lying south and east of the Milk River; in range 12;

All the above described lands lying west of the fourth meridian.

*Division No. 2:*

The northerly one-third of township 3; and all of townships 4 to 6 inclusive; all in range 5;

All of townships 1 to 6 inclusive; in range 6;

All of townships 1 to 6 inclusive; in range 7;

All of townships 1 to 6 inclusive; in range 8;

All the above described lands lying west of the fourth meridian.

*Division No. 3:*

All of townships 4 to 6 inclusive; in range 12;

All of townships 4 to 6 inclusive; and sections 3, 4, 5, 6 and the south halves of sections 1, 2, 7, 8 and 9 in township 7; all in range 13;

All of townships 5 and 6; and sections 1 to 12 inclusive and sections 16, 17, 18 and the south halves of sections 14 and 15 in township 7; all in range 14;

All the above described lands lying west of the fourth meridian.

*Division No. 4:*

The north half of township 5; and all of townships 6 and 7; all in range 9;

The north half of township 5; and all of townships 6 and 7; all in range 10;

The north half of township 5; and all of townships 6 and 7; all in range 11;

All of township 7; in range 12;

All the above described lands lying west of the fourth meridian.

*Division No. 5:*

All of township 7 excepting thereout section 1, 12, 13, 24, 25 and 36; the west half of township 8; and sections 4 to 9 inclusive in township 9; all in range 5;

All of townships 7 and 8; and the southerly one-third of township 9; all in range 6;

All of townships 7 to 9 inclusive; in range 7;

All of townships 7 to 9 inclusive; and the south half of township 10 excepting thereout sections 1, 12, 13 and the east halves of sections 2, 11 and 14; all in range 8;

All of townships 8 and 9; and the south half of township 10; all in range 9;

All the above described lands lying west of the fourth meridian.

*Division No. 6:*

All of townships 8 and 9; and the south half of township 10; all in range 10;

All of townships 8 and 9; and the south half of township 10; all in range 11;

All of townships 8 and 9; and the south half of township 10; all in range 12;

All the above described lands lying west of the fourth meridian.

*Division No. 7:*

The north half of township 10 excepting thereout sections 24, 25, 36 and the east halves of sections 23, 26 and 35; all of township 11 excepting thereout sections 1, 12, 13, 24, 25, 36 and the east halves of sections 2, 11, 14, 23, 26 and 35; all of township 12 lying south of the South Saskatchewan River excepting thereout sections 1, 12, 13, 24 and the east halves of sections 2, 11, 14, 23 and those portions of section 25 and the east half of section 26 lying south of the South Saskatchewan River; and that portion of township 13 lying south of the South Saskatchewan River; all in range 8;

The north half of township 10; all of townships 11 and 12; and that portion of township 13 lying south of the South Saskatchewan River; all in range 9;

The north half of township 10; all of township 11; and those portions of townships 12 and 13 lying south and east of the South Saskatchewan River; all in range 10;

The north half of township 10; and those portions of townships 11 and 12 lying south and east of the South Saskatchewan River; all in range 11;

The north half of township 10; and that portion of township 11 lying south of the South Saskatchewan River; all in range 12;

All the above described lands lying west of the fourth meridian.

That the Council of the said Municipal District hereby constituted shall consist of seven members, one councillor to be elected from each of the said divisions and the candidate with the highest number of votes in each division shall be declared the councillor for that division.

That Tuesday, February 2nd, 1954, be fixed as the date for receiving nominations for the office of councillor for each of the said divisions.

That the place for receiving nominations for the office of councillor shall be designated by the Returning Officer.

That the Returning Officer appointed to conduct the said nominations and election (if any) shall, at least seven clear days before the nomination day post up or cause to be posted up a Notice in the form set out in the second part of Form H in the Schedule to the Municipal District Act in accordance with the provisions of sections 45 and 46 of the said Act.

That the Returning Officer shall divide the Municipality into polling divisions and name a polling place or places therefor, and appoint such Deputy Returning Officers and Poll Clerks as are necessary.

That if a Poll be required for any electoral divisions of the said Municipal District it shall be held on Tuesday, March 2nd, 1954, from 9 o'clock a.m. to 5 o'clock p.m.

That Leo Rene Maurice be, and he is hereby appointed, to prepare or cause to be prepared a voter's list of the said Municipal District of Forty Mile No. 2, in the manner set out in sections 27 and 28 of the Municipal District Act and for such purpose shall have access to the assessment rolls and the voter's lists of the Municipal Districts and Improvement Districts which are in whole or in part merged by this Order into the Municipal District of Forty Mile No. 2, and the said Leo Rene Maurice shall in compiling or causing to be compiled the said voter's list comply as far as possible with the provisions of sections 30a, 30b and 31 of the Municipal District Act and carry out or cause to be carried out all the duties imposed by said sections upon the Secretary-Treasurer of a Municipal District at the time and in the manner required of a Secretary-Treasurer.

That the said Leo Rene Maurice shall appoint such enumerators as are required by section 43 (1) of The Municipal District Act.

That the first meeting of the newly elected council shall be held at a place to be designated by the Official Administrator at 2 p.m. on Friday, March 19th 1954.

That this Order shall become effective on the 1st day of January, 1954, except for the purpose of Certificates of Assessment as required by sections 283 and 296 of The School Act, 1952, and section 73 of The Municipal Hospitals Act this Order shall be deemed to have been in effect as of the 31st day of December, 1953.
