The Executive Council has had under consideration the report of the Honourable the Minister of Municipal Affairs, dated December 18th, 1957, stating that:

<u>WHEREAS</u> pursuant to the provisions of section 3(1) of The County Act, being chapter 64 of the Revised Statutes of Alberta, 1955, a resolution has been received from the council of the Municipal District of Forty Mile No. 2 that the Municipal District of Forty Mile No. 2 be formed into a County; and

WHEREAS it is considered advisable and expedient to do so;

THEREFORE, upon the recommendation of the Honourable the Minister of Municipal Affairs, the Executive Council advises that, the resolution to form a County in this area be and is hereby implemented and that on and after, the First day of January 1958 the County shall be incorporated and known as "The County of Forty Mile No. 8" and shall comprise the following lands:

The north one-third of township 3; all of townships 4 to 6 inclusive; all of township 7 excepting thereout sections 1, 12, 13, 24, 25 and 36; sections 4 to 9 inclusive and 16 to 21 inclusive in township 8; all in range 5.

All of townships 1 to 7 inclusive; sections 1 to 24 inclusive, the north-west quarter of section 28, sections 29 to 32 inclusive, all in township 8; sections 5 to 8 inclusive in township 9; all in range 6.

All of townships 1 to 9 inclusive; all in range 7.

All of townships 1 to 9 inclusive; all of township 1C excepting thereout sections 1, 12, 13, 24, 25 and 36 and the east halves of sections 2, 11, 14, 23, 26 and 35; all of township 11 excepting thereout sections 1, 12, 13, 24, 25 36 and the east halves of sections 2, 11, 14, 23, 26 and 35; that part of township 12 lying south of the South Saskatchewan

All of the above described lands lying west of the fourth meridian excepting thereout the land comprising any incorporate town or village situate therein.

That the aræincluded by this Order within the above described boundaries of the County of Forty Mile No. 8, shall be and is divided into nine divisions for electoral purposes described as follows;

# DIVISION NO. 1

Those parts of townships 1 and 2 lying south of the Milk River; all in range 6.

All of township 1; that part of township 2 lying south of the Milk River, in ranges 7, 8 and 9 inclusive.

All of townships 1, 2 and 3; the west two-thirds of township 4; the west two-thirds of township 5; all in range 10

That part of the east two-thirds of township 2 lying north of the Milk River, the east two-thirds of township 3, all of township 4; sections 1 to 18 inclusive; the east half of section 23, sections 24 and 25; all in township 5; all in range 11.

All of township 4; sections 1 to 15 inclusive, the south halves of sections 16 and 17, all in township 5; all in range 12.

All the above described lands lying west of the fourth meridian.

The north one-third of township 3; all of townships 4 to 6 inclusive; all of township 7 excepting thereout sections 1, 12, 13, 24, 25 and 36; sections 4 to 9 inclusive and 16 to 21 inclusive in township 8; all in range 5.

All of townships 1 to 7 inclusive; sections 1 to 24 inclusive, the north-west quarter of section 28, sections 29 to 32 inclusive, all in township 8; sections 5 to 8 inclusive in township 9; all in range 6.

All of townships 1 to 9 inclusive; all in range 7.

All of townships 1 to 9 inclusive; all of township 10 excepting thereout sections 1, 12, 13, 24, 25 and 36 and the east halves of sections 2, 11, 14, 23, 26 and 35; all of township 11 excepting thereout sections 1, 12, 13, 24, 25, 36 and the east halves of sections 2, 11, 14, 23, 26 and 35; that part of township 12 lying south of the South Saskatchewan River excepting thereout sections 1, 12, 13, 24 and 25 and the east halves of sections 2, 11, 14, 23 and 26; and that part of township 13 lying south of the South Saskatchewan River; all in range 8 All of townships 1 to 12 inclusive; that part of township 13 lying south of the South Saskatchewan River; all in range 9:.

That the area included by this Order within the above described boundaries of the County of Forty Mile No. 8, shall be and is divided into nine divisions for electoral purposes described as follows:-

#### DIVISION NO. 1

Those parts of townships 1 and 2 lying south of the Milk River; all in range 6.

All of township 1; that part of township 2 lying south of the Milk River, in ranges 7, 8 and 9 inclusive.

All of townships 1, 2 and 3; the west two-thirds of township 4; the west two-thirds of township 5; all in range 10.

That part of the east two-thirds of township 2 lying north of the Milk River, the east two-thirds of township 3, all of township 4; sections 1 to 18 inclusive; the east half of section 23, sections 24 and 25; all in township 5; all in range 11.

All of township 4; sections 1 to 15 inclusive, the south halves of sections 16 and 17, all in township 5; all in range 12.

All the above described lands lying west of the fourth meridian.

### DIVISION NO. 2
