

MINISTERIAL ORDER NO. 429/68

To Provide for Establishment of Improvement District No. 17.

THE IMPROVEMENT DISTRICTS ACT, 1965

Edmonton, December 19, 1968.

Whereas, under the provisions of The Improvement Districts Act, 1965, the Minister may, by order, amalgamate any two or more Improvement Districts, or alter the boundaries thereof;

Therefore, I, Edgar H. Gerhart, Minister of Municipal Affairs, by virtue of the powers vested in me by section 4 of the said Act, do hereby order, that the undernoted Improvement Districts be amalgamated:

Nos. 107, 122, 123, 124, 125, 128, 129 and 131.

It is further ordered, that the amalgamated district thus created, be numbered 17, and shall comprise the lands described in the Schedule hereto.

This order shall be effective as of January 1, 1969, except for assessment purposes where the effective date will be December 31, 1968.

## IMPROVEMENT DISTRICT NO. 17

- Townships 65 and 66—All of the west two-thirds of range 25 and all of ranges 26 and 27;
- Townships 67 and 68—All of ranges 25 to 27 inclusive;
- Township 69 —All those portions of ranges 18 and 19 lying west of the Athabasca River and all of ranges 23 to 27 inclusive;
- Township 70 —All those portions of ranges 18 and 19 lying west of the Athabasca River and all of ranges 20 to 27 inclusive;
- Township 71 —All those portions of range 19 lying west of the Athabasca River and all of ranges 20 to 26 inclusive;
- Townships 72 to 76 inclusive —All those portions of ranges 18 and 19 lying west of the Athabasca River and all of ranges 20 to 26 inclusive;
- Townships 77 to 85 inclusive —All those portions of ranges 17 and 18 lying west of the Athabasca River and all of ranges 19 to 26 inclusive;
- Townships 86 to 88 inclusive —All of ranges 20 to 26 inclusive;
- Townships 89 to 91 inclusive —All those portions of ranges 23 to 25 inclusive lying west and south of the Wabasca River;
- All of the above lands lying west of the fourth meridian.
- Township 65 —All of range 1 and all those portions of ranges 2 and 3 lying east of the Athabasca River and all of ranges 8 to 13 inclusive;
- Township 66 —All of range 1 and all those portions of ranges 2 and 3 lying east of the Athabasca River and all of ranges 8 to 13 inclusive;
- Township 67 —All of range 1 and all those portions of range 2 lying east of the Athabasca River and all of ranges 8 to 13 inclusive;
- Townships 68 to 73 inclusive —All of ranges 1 to 19 inclusive;
- Townships 74 to 77 inclusive —All of ranges 1 to 18 inclusive;
- Township 78 —All of ranges 1 to 18 inclusive and sections 1 and 2, 8 to 17 inclusive, 20 to 29 inclusive, 32 to 36 inclusive all in range 19;
- Township 79 —All of ranges 1 to 19 inclusive;
- Township 80 —All of ranges 1 to 19 inclusive and N.½ of ranges 20 and 21;

- Townships 81 and 82**—All of ranges 1 to 21 inclusive and those portions of ranges 22 and 23 lying east of the Smoky River;
- Township 83** —All of ranges 1 to 20 inclusive and those portions of ranges 21 and 22 lying east of the Smoky River and the Peace River;
- Township 84** —All of ranges 1 to 20 inclusive and those portions of range 21 lying east of the Peace River;
- Township 85** —All of ranges 1 to 19 inclusive and those portions of ranges 20 and 21 lying east of the Peace River;
- Townships 86 to 88 inclusive** —All of ranges 1 to 19 inclusive and those portions of range 20 lying east of the Peace River;
- Townships 89 and 90**—All of ranges 1 to 5 inclusive;
- Township 91** —All of those portions of ranges 1 to 4 inclusive lying west and south of the Wabasca River and all of range 5;

All of the above lands lying west of the fifth meridian, excepting therefrom the area contained within the limits of any town or village, as the case may be.
