NEW TOWN OF HINTON ESTABLISHED

Edmonton, Tuesday, November 6, 1956.

The Executive Council has had under consideration the report of the Honourable the Acting Minister of Municipal Affairs, dated November 6th, 1956, stating that:

Whereas the Development Officer of Improvement Districts numbered 79, 95 and 96, pursuant to section 4 of The New Towns Act had made application to the Provincial Planning Advisory Board for the establishment of the hamlet of Hinton as a new town; and

Whereas the Provincial Planning Advisory Board, having considered the application, have made certain recommendations with regard thereto; and

Whereas it is desirable and in the public interest to establish the hamlet of Hinton as a new town;

Therefore, upon the recommendation of the Honourable the Acting Minister of Municipal Affairs, the Executive Council advises that, pursuant to the provisions of sections 3, 5 and 13 of The New Towns Act, being chapter 39 of the Statutes of Alberta, 1956:

- (1) All that portion of the north-west quarter of section 10, the south half of section 15 and the south-west quarter of section 14 in township 51, range 25, west of the fifth meridian, lying south of the north boundary of the railway right of way of the Canadian National Railway registered under Plan No. 7415 A.H. and the north-east quarter of section 10 and the north-west quarter of section 11 in township 51, range 25, west of the fifth meridian, be and is hereby declared to be a new town to be known as the New Town of Hinton.
- (2) The establishment of the New Town of Hinton shall be effective as, on, and from the 1st day of November, 1956.
- (3) The Board of Administrators of the New Town of Hinton shall consist of:
 - W.D. Isbister, Assistant Chief Municipal Inspector, Department of Municipal Affairs.
 - A. B. MacKenzie, Liaison Officer, Department of Municipal Affairs.
 - D. L. Lawson, Supervisor of Miscellaneous Leases and Secretary of Provincial Parks, Department of Lands and Forests.
 - R. Fuller, Garage Proprietor, Hinton.
 - R. Lisogar, Hotel Proprietor, Hinton.

Fred Hansen, Proprietor, Hinton.

- (4) The said W. D. Isbister be and is hereby appointed chairman of the said board.
- (5) An advance in the sum of \$8,500.00 be made available to finance current operations.

(6) A further advance in the sum of \$18,500.00 be made available to finance the installation of the preliminary stage of the sewer and water system to the high density commercial area as follows:

Labour and contractor's charges\$	9,400.00
Material	6,000.00
Connecting pumps to system	1,500.00
Engineering and contingencies	1,600.00

Total \$18,500.00

AGREEMENT BETWEEN THE GOVERNMENT OF CANADA AND THE GOVERNMENT OF THE PROVINCE OF ALBERTA

Edmonton, Wednesday, November 7, 1956.

The Executive Council has had under consideration the report of the Honourable the Minister of Lands and Forests, dated November 5th, 1956, stating that:

Whereas it is enacted by clause (a) of section 6 of the Canada Forestry Act, being chapter 24 of the Revised Statutes of Canada, 1952, that the Minister may with the consent of the Governor in Council enter into agreements with any province for the protection, development or utilization of forest resources, including protection from fire, insects and diseases, forest inventories, silvicultural research, watershed protection, reforestation, forestry publicity and education, construction of roads and improvement of streams in forest areas, improvement of growing conditions and management of forests for continuous production; and

Whereas the agreement hereunto annexed relating to forest inventories and reforestation in the Province is an agreement within the meaning of the said clause (a) of section 6; and

Whereas the agreement hereunto annexed has been approved by the Governor in Council by order in council P.C. 1956-15-1415 dated September 20th, 1956; and

Whereas the said agreement is satisfactory to the Government of the Province and it is proper and convenient that it be signed by the Minister of Lands and Forests on its behalf;

Therefore, upon the recommendation of the Honourable the Minister of Lands and Forests, the Executive Council advises that the Lieutenant Governor in Council hereby approves the agreement in the form hereunto annexed and that the said agreement be signed and delivered on behalf of the Government of the Province of Alberta by the Honourable Norman Willmore, Minister of Lands and Forests.
