




Lieutenant Governor.

R E G I N A, SATURDAY, JUNE 20, 1903.

The Executive Council has had under consideration a report from the Attorney General, bearing even date, stating that he has had under consideration the petition of the Overseer of the Village of Raymond for the erection of the said Village into a town municipality, under the provisions of The Municipal Amendment Ordinance 1901; and that satisfactory proof of the preliminary acts and requirements requisite to the erection of the said Village into a Town has been furnished.

Upon consideration of the foregoing report and on the recommendation of the Attorney General, the Executive Council advises that, under the provisions of the said Ordinance, a proclamation do issue proclaiming that on from and after the First day of July, 1903, the said Village of Raymond be erected into a town municipality to be known as the Town of Raymond; that the area of the said Town of Raymond consist of the whole of sections 7, 8, 17 and 18, and those portions of sections 9 and 16 lying west of a line drawn parallel to and 476 feet perpendicularly distant easterly from the western boundary of the said sections 9 and 16, all in township 6 range 20 west of the Fourth Meridian, in the District of Alberta; and that Edward McCarthy be named as the Returning Officer for the holding of the first election of mayor and councillors for the said Town.

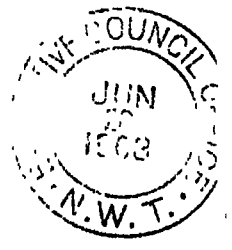

To His Honour

The Lieutenant Governor in Council:

The undersigned has the honour to report that he has had under consideration the petition of the Overseer of the VILLAGE OF RAYMOND for the erection of the said Village into a town Municipality under the provisions of "The Municipal Amendment Ordinance, 1901."

The undersigned further reports that satisfactory proof of the preliminary acts and requirements requisite to the erection of the said Village into a Town has been furnished:

The undersigned therefore recommends that Your Honour's proclamation do issue proclaiming that on from and after the 1st day of July, 1903, the said Village of Raymond be erected into a town municipality to be known as the TOWN OF RAYMOND and that the area of the said Town of Raymond consist of ~~all~~ the whole of sections 7, 8, 17 and 18, and those portions of sections 9 and 16 lying west of a line drawn parallel to and 476 feet perpendicularly distant easterly from the western boundary of the said sections 9 and 16, all in Township 6, Range 20, West of the 4th Meridian, in the District of Alberta.

The undersigned further recommends that Edward McCarthy be named as the returning officer for the holding of the first election of mayor and councillors for the said town.
