

Edmonton, Friday, June 14th, 1912

The Hon. the Minister of Municipal Affairs reports, under date of June 11th, 1912, that, having received satisfactory proof that the area mentioned hereunder is not contained within any incorporated city, town or rural municipality, and that the said area contains not less than twenty-five occupied dwelling houses, he has, in accordance with the provisions of Section 3 of The Village Act, caused Notices to be posted in three conspicuous places within the said area, one of which was the Post Office, announcing the intention to establish the area as a Village at the expiration of thirty days from the date of posting such Notices.

The Hon. the Minister of Municipal Affairs further reports that such notices were posted at least thirty days prior to the date hereof.

Therefore, upon the recommendation of the Hon. the Minister of Municipal Affairs, the Executive Council advises that, under the provisions

of Section 4 of The Village Act, Legal Subdivision thirteen (13) in Section four (4), Legal Subdivisions thirteen (13), fourteen (14), fifteen (15) and sixteen (16) in Section five (5), Legal Subdivisions fifteen (15) and sixteen (16) in Section six (6), Legal Subdivisions one (1) and two (2) in Section seven (7), Legal Subdivisions one (1), two (2), three (3) and four (4) in Section eight (8), and Legal Subdivision four (4) in Section nine (9), all in Township fifty-eight (58), Range nine (9), West of the Fourth Meridian, be established a Village; that the Village be given the name of ST. PAUL DE METIS; that Mr. Clovis Therien, of St. Paul de Metis, Alberta, be Returning Officer for the purpose of acting at the election of the first Council of the village; and that the meeting for the nomination of candidates for the office of Councillor shall be held on Monday, the twenty-fourth day of June, 1912.
