- This high level overview depicts *potential* grant stacking combinations and is based on program guidelines that were current at the time it was created.
- The program list is not exhaustive. For programs not listed, please contact the administering ministry.

Grant stacking: refers to the application of funding from more than one provincial and/or federal grant programs to the same project. Grant stacking is commonly used where programs have a cost-sharing requirement and/or so that applicants can acquire more grant funding for a single project. If a municipality chooses to use multiple grant sources to fund an activity, it is the responsibility of the municipality to understand the separate requirements of each program as well as requirements under a stacked scenario. This includes additional approvals, reporting, applications, as well as cost-sharing requirements or limits.

Cost-Sharing (also known as “leveraging”): a requirement under some programs, the purpose of cost-sharing is to leverage investments/funds from other governments/funding partners. Generally, cost-share requirements stipulate that a specific portion of the project cost be funded by a separate government or entity from the municipality applying for the grant. Cost-sharing demonstrates buy-in from more than one party, showing a shared responsibility for the project.
