

**UNCERTIFIED APPLIANCES AND EQUIPMENT  
REQUIRE SPECIAL INSPECTION AND APPROVAL**

In Alberta, under the **Safety Codes Act**, the inspection and approval of uncertified gas-fired appliances and equipment is to be conducted by nationally recognized certification bodies or inspection bodies accredited by the Standards Council of Canada.

**A special inspection is not intended to be used as a means to accept appliances and equipment when certified products of similar type are available.**
