# Consolidation of the 2005 Minister's Guidelines Regarding Farm Land, Linear Property, Machinery and Equipment and Railway Property Assessment

# 1.000 DEFINITIONS

- (a) **Act** means the *Municipal Government Act* (RSA 2000, Ch.M-26)
- (b) assessor has the meaning given to it in the Act
- (c) *farming operations* has the meaning given to it in the Regulation;
- (d) *linear property* has the meaning given to it in the Act;
- (e) *machinery and equipment* has the meaning given to it in the Regulation;
- (f) Minister has the meaning given to it in the Act;
- (g) *municipality* has the meaning given to it in the Act;
- (h) railway has the meaning given to it in the Act.
- (i) **regulation** means the Matters Relating to Assessment and Taxation Regulation (AR 220/2004)

### 2.000 GENERAL

Pursuant to section 4(2) of the Regulation, the assessor appointed by the municipality must follow the procedures set out in the 2005 Alberta Farm Land Assessment Minister's Guidelines.

Pursuant to section 7 of the Regulation, the assessor appointed by the municipality must follow the procedures set out in the 2005 Alberta Railway Property Assessment Minister's Guidelines.

Pursuant to section 8 of the Regulation, the assessor designated by the Minister must follow the procedures set out in the 2005 Alberta Linear Property Assessment Minister's Guidelines.

Pursuant to section 9 of the Regulation, the assessor appointed by the municipality must follow the procedures set out in the 2005 Alberta Machinery and Equipment Assessment Minister's Guidelines.

## 3.000 APPLICATION

Pursuant to sections 4, 7, 8, 9 in the *Matters Relating to Assessment and Taxation Regulation*, the Consolidation of the *2005 Minister's Guidelines* regarding Farm Land, Linear Property, Machinery and Equipment and Railway Property Assessment consists of:

- (a) Appendix I 2005 Alberta Farm Land Assessment Minister's Guidelines,
- (b) Appendix II 2005 Alberta Linear Property Assessment Minister's Guidelines,
- (c) Appendix III 2005 Alberta Machinery and Equipment Assessment Minister's Guidelines,
- (d) Appendix IV 2005 Alberta Railway Property Assessment Minister's Guidelines, and
- (e) Appendix V 2005 Construction Cost Reporting Guide,

and are referred to collectively as the Minister's Guidelines.
