Item: 7 Liability Code Update #3

Title: Liability Coding Requirements - Exemption Code Revision

The exemption codes that will be required by the ASSET system by 2005 have been condensed from the full legislative reference, e.g. MGA362(1)(d)(i)(A) to an abbreviated reference that includes the act, section, subsection and clause, e.g. MGA362(1)(d). This, in effect, collapses some of the codes in the previous list. For example:

Previous requirement

Exemptions for Government, churches and other bodies MGA 362 (1)(d) (i)(A) a university under the Universities Act;

Amended requirement

Exemptions for Government, churches and other bodies MGA 362 (1)(d) a university under the Universities Act;

When data is being prepared for entering into the ASSET system, the exemption reason is a mandatory field, therefore, municipalities are required to enter the "NAA" code in the field in lieu of the Tax Exemption code, for all accounts, including those that are not exempt from taxation.

Beginning in 2005, municipalities must provide the exemption code for accounts that are exempt from taxation, or the "NAA" code for those accounts that are not exempt, to satisfy system requirements. However, municipalities may begin entering the tax exemption codes prior to 2005 if they have the capability.

Coding changes - Requisitioning Bodies

In response to a request for municipalities to review the requisitioning bodies within their jurisdictions and to the provincial review of the Region Health Authorities, changes have been made to the liability codes provided for requisitioning bodies.



Regional Health Authority boundary changes became effective April 1, 2003. As a result, the codes provided to municipalities have been revised. For information on changes made to the Regional Health Authorities, visit Alberta Health's Web site at: http://www.health.gov.ab.ca/system/Rhas/.

Coding clarifications

To facilitate the process of assigning the liability code, Alberta Municipal Affairs provides the following information.

Assessable Person Code

The assessable person code for school, hospital and nursing homes is "C" corporate, as the local authorities (boards) that operate these facilities are considered to be corporations under provincial legislation. Please note that these facilities are not included in the preparation of the equalized assessment and are not subject to either municipal or school property taxation.

Grant in Place of Taxes Code

Properties, such as seniors self contained units that receive grants for the municipal property tax portion, and are exempted from school property taxes through Ministerial Order, must be coded as "X" (exempt from the equalized assessment, but subject to municipal tax).

Only properties receiving grants in place of both municipal and school taxes are to be coded as "G" (grant in place of taxes).

Please discard all past liability code listings and retain the attached copy of the revised Liability Code. The complete updated liability code requirement can be accessed through Municipal Affairs' website at www3.gov.ab.ca/ma.

Note: The liability coding requirements represent the minimum coding necessary for the province to determine equalized assessments and education property tax requisitions. Municipalities may wish to expand the liability codes for their own purposes. The expanded codes must, however, be collapsible into the minimum liability coding requirements for reporting to the department.

Alberta Municipal Affairs appreciates your support in making the transition to the ASSET system a smooth one.

Notes:

¹ NRL is the primary code that will be applied to all linear property. It will precede a secondary code that will be used to identify specific categories of linear properties. An example of this is linear telecommunications which will be coded as NRL-T. These codes will be assigned to all linear properties by the Assessment Services Branch, Linear Property Assessment Unit.
