Municipal Government Amendment Act, 2015 (Bill 20)

Sections 1, 8, 33, 34(a) and (c), 35, 36, 48, 51, 60, 79(d)(f)(g) and (k) and 80 of the *Municipal* Government Amendment Act, 2015 have been proclaimed and are coming into force on March 1, 2016.

The purpose of this proclamation is to implement a long-term legislative solution for several temporary regulations made under Section 603 of the Municipal Government Act (MGA), either by elevating their substance directly into the Act or by exercising new regulation-making authorities contained in Bill 20.

None of the sections result in a change to government policy, only the legislative mechanisms used to implement the existing policy will change.
