#### **REGULATION AR 387/2003**

## BALLOT BOX REGULATION – 387/2003 LOCAL AUTHORITIES ELECTION ACT (Consolidated up to 165/2012)

#### Definitions

- 1. In this regulation,
  - (a) "seal" means a closing device or method applied to a ballot box in accordance with the Act that must be broken in order for the ballot box to be opened;
  - (b) "tape" means tape that has adhesive on one side and is of sufficient strength that it cannot be removed from a cardboard ballot box without being cut or without defacing the cardboard ballot box.

#### Permanent ballot boxes

2. Each ballot box shall be made of durable material and constructed that ballots can be deposited into the ballot box and cannot be removed from it unless the seal broken and the ballot box is opened.

#### Cardboard ballot boxes

- 3. (1) Notwithstanding section 2, an elected authority may use cardboard ballot boxes if each cardboard box used
  - (a) is constructed of a minimum 175-pound test cardboard,
  - (b) meets the following minimum dimensions, as shown in the Schedule:
    - (i) width, 22 centimetres;
    - (ii) length, 36 centimetres;
    - (iii) height, 36 centimetres;
  - (c) has four flaps at each side, as shown in the Schedule, that meet or overlap when closed and taped, so as to prevent the removal of ballots unless the ballot box is opened by cutting the tape, and

(d) has one slot for the deposit of ballots, the width of which is 0.5 centimetres and location and the length of which is discretionary.

(2) A cardboard ballot box must be closed and must be sealed by closing the flaps and placing a piece of tape over the entire adjoining edges and the ends of the closed flaps, such that the tape prevents the flaps from being opened without first cutting the tape.

#### Repeal

4. The Ballot Box Regulation (AR 144/2000) is repealed.

#### Expiry


5. For the purpose of ensuring that this Regulation is reviewed for ongoing relevancy and necessity, with the option that it may be repassed in its present or an amended form following a review, this Regulation expires on October 31, 2015.


### Schedule

#### Minimum Dimensions of a Closed Cardboard Ballot Box

Slot location and slot length are discretionary. Slot width is 0.5 centimetres.

## FORMS REGULATION LOCAL AUTHORITIES ELECTION ACT

- 1 (1) The forms set out in Schedule 1 are the English forms for use under the *Local Authorities Election Act.* 
  - (2) The forms set out in Schedules 2 and 3 are the forms for use under the Local Authorities Election Act for the election of members of a Regional authority as defined in the School Act. (not included)
- 2 If a council has passed a resolution under section 155 of the *Municipal Government Act*, the title directed by that council for "councillor" or "chief elected official" is the title that may, in that local jurisdiction, replace councillor or chief elected official on the forms in the Schedules.
- 3 For the purpose of ensuring that this Regulation is reviewed for ongoing relevancy and necessity, with the option that it may be repassed in its present or an amended form following a review, this Regulation expires on October 31, 2017.
- 4 The forms contained in Schedule 1 are found in the Appendix of this document.

#### **REGULATION AR 5/2007**

## MODIFIED VOTING PROCEDURE REGULATION LOCAL AUTHORITIES ELECTION ACT

#### Definition

1. In this Regulation, "Act" means the Local Authorities Election Act.

#### **Designating locations of voting stations**

- 2. Where an elected authority has passed a bylaw in accordance with section 160(2) of the Act, section 37 of the Act is modified as follows:
  - (a) the returning officer of the elected authority may designate the location of the voting station;
  - (b) the location of more than one voting station may be designated for each voting subdivision.

#### **Elector's statement**

3. The statement required under section 77 of the Act is Form 8 as prescribed in Schedule 1 to the *Local Authorities Election Forms Regulation* (AR 378/2003).

#### **Blind voter template**

4. Despite section 78(5) of the Act, where an elected authority has passed a bylaw in accordance with section 160(2) of the Act, the returning officer of the elected authority may determine the form of the blind voter template to be provided to an elector under that section.

#### Appointing deputies to take votes of electors unable to attend voting station

- 5. Despite section 79(1) and (3) of the Act, where an elected authority has passed a bylaw in accordance with section 160(2) of the Act,
  - (a) the elected authority may define lodge accommodation as a home, including a self-contained housing unit, for the use of persons of advanced years who
    - (i) are not suffering from any chronic disease that incapacitates them, and

(ii) may or may not be capable of or desirous of maintaining their own housing accommodation,

#### and

(b) the returning officer of the elected authority may appoint the number of deputies that the returning officer considers necessary to take the votes of electors who reside in lodge accommodation, as defined under clause (a), and are unable to attend a voting station or advance voting station to vote.

#### Repeal

6. The Modified Voting Procedure Regulation (AR 170/2000) is repealed.

#### Expiry

 For the purpose of ensuring that this Regulation is reviewed for ongoing relevancy and necessity, with the option that it may be repassed in its present or an amended form following a review, this Regulation expires on November 30, 2016.




## A SUGGESTED VOTING STATION ARRANGEMENT
